This contract is subject to the following conditions:

- It is mutually agreed, that this contract is granted to the above listed Vendor, by Macon County Fair Association, Inc. hereafter "Fair" for the sole and only purpose of displaying and selling goods and/or services at the Fair-ly Crafty Craft Show, June 8, 2019, at the ADM Building on the Macon County Fairgrounds.
- The said Vendor agrees to pay a flat fee of
 - \$30.00 for a 8 ft x 12 ft space with one 8' folding table and 2 chairs; or
 - \$30.00 for a 10 ft x 10 ft space with one 8' folding table (without electricity) and 2 chairs; or
 - \$35.00 for a 10 ft x 10 ft with one 8' folding table, and 2 chairs with one 110 electrical outlet available. Extension cords not provided by Fair. Limited number of spots with electricity available on a first come, first serve basis.
 - \$5.00 rental fee per extra 8 foot folding table. Number requested: _____ * \$5.00 = \$_____
- Payment with a signed Contract reserves your spot on a first come, first serve basis. No refunds will be given after June 2, 2019.
- Vendors may check in any time after 6:00 a.m. on Saturday, June 8, 2019. Vendors must be in place and ready for operation by 8:50 a.m. All items must be removed by 5:00 p.m. on Saturday, June 8, 2019. The *Fair-ly Crafty Craft Show* will be open to the public from 9:00 a.m. to 3:00 p.m. on Saturday, June 8, 2019.
- Your space must be manned during the hours above. You alone are responsible for all items in your exhibit. The Macon County Fair Association, Inc. will not be responsible for any damage or loss of property.
- Only the sale or distribution of goods/services and information described above are allowed under this contract and must be contained within your assigned space. No roving activities are permitted. Each Vendor must comply with all federal, state, and local laws, rules and regulations.
- This contract is not transferrable or assignable.
- In case the Vendor or their employees and agents violate any federal, state, or local laws, rules or regulations, or conditions herein, all further right to transact business under this contract shall, at the option of the Macon County Fair Association, Inc. at once become forfeited without any right of the said Vendor to recover any part of the money that has already been paid on this contract. Said Vendor and their equipment shall be removed from the fairgrounds without delay.
- The Vendor agrees to indemnify and hold harmless the Macon County Fair Association, Inc. and its officers and directors from any and all liability resulting from operations under this contract.
